The court set this matter for hearing to address two issues in the movant's proposed order.

First, the proposed order includes language that the debtor must provide "direct access to [] electronic data, on the device or online account in which such records were kept." No explanation or authority is given in the motion for this provision.

Second, the motion seeks, and the proposed order includes, language requiring the chapter 7 trustee to turn over any responsive records to the movant, citing 28 U.S.C. 959. This section of the Judicial Code, however, only states that the trustee must hold property subject to the same state law obligations that the debtor would be bound to. It does not compel a trustee to comply with a Rule 2004 order against a debtor. If the movant wants to seek documents or an examination of the trustee pursuant to Rule 2004, it may do so separately, after meeting and conferring with the trustee and following all appropriate procedures for such a motion.
