The court set this motion for hearing because the amount of the preferential transfers could not be determined. There is one check listed outside the lookback period (which the plaintiff appears to have taken out on the default judgment motion). There is another check, listed twice -- once with a positive amount of \$67,438 and once with a negative amount of (\$23,760). The motion does not explain this treatment or whether and why the amounts should be netted. What is the amount sought by the motion, and what is the basis for that amount? Clearer evidence of the preferences to be recovered is needed.

In addition, as with other matters on calendar for today, the lodged default judgment order included only the §§ 547 and 550 claims, leaving pending §§ 502(d), 548, and 551 claims. What does the movant intend to do regarding the other claims?

Tentative Ruling:

The court set this motion for hearing because the schedule of preferential payments raises several questions. First, there is a check listed twice with one positive number and one negative number (Check 155524). Based on the amount sought in the motion, it appears that the plaintiff seeks to recover as if both checks reflect payments (positive numbers), while the complaint had applied the negative amount as a deduction to the alleged preferences. In addition, there are other checks listed repeatedly with multiple figures – Check 155727 is listed twice, and Check 156033 is listed three times. Clearer evidence of the preferences to be recovered is needed.

In addition, as with other matters on calendar for today, the lodged default judgment order included only the §§ 547 and 550 claims, leaving pending §§ 502(d), 548, and 551 claims. What does the movant intend to do regarding the other claims?
