Summary of Facts and Pleadings

On July 31, 2016, Richard Anthony Midel ("Debtor") filed for voluntary chapter 7 relief ("Petition"). Doc. No. 1. Stephen L. Burton ("Counsel") represented the Debtor. *Id.* The Petition included a Disclosure of Compensation of Attorney for Debtor ("Disclosure"). *Id.* Counsel signed the Disclosure and agreed to accept \$1,195.00 for legal services, which included the preparation and filing of the petition and schedules, and representation of Debtor at his § 341(a) meeting. *Id.* On August 1, 2016, the Court filed a Notice of Dismissal stating that Counsel had failed to submit an Electronic Filing Declaration, which is required by Local Bankruptcy Rule ("LBR") 1006-1(h). Doc. No. 2. Moreover, the Notice of Dismissal stated that Counsel failed to file a Statement of Social Security Number (Official Form 121) ("Statement"), as required by Federal Rule of Bankruptcy Procedure ("FRBP") 1007 (f) and LBR 1002-1. *Id.* According to the Notice of Dismissal, "the debtor and/or debtor's attorney must submit the above stated documents and/or information within

72 hours from the date of this notice or the case will be dismissed without further notice by the Court.” *Id.* On August 2, 2016, Counsel filed an Electronic Filing Declaration. Doc. No. 8. However, Counsel did not file the Statement and, subsequently, the Court dismissed the case on August 5, 2016. Doc. No. 12.

The United States Trustee (“UST”) moves to disgorge all payments received by Counsel. The UST avers that the services provided by Counsel were incomplete and provided little benefit to the Debtor, evidenced by Counsel’s failure to cure the Notice of Dismissal within seventy-two hours and the eventual dismissal. Motion at 5. The UST contends that the \$1,195.00 the Debtor paid exceeds the reasonable value of the services provided because Counsel did not properly prepare the Debtor’s Petition and did not represent the Debtor at contracted-for § 341(a) meeting. *Id.* Thus, the UST argues for sufficient cause to order disgorgement of the fees collected in failing to competently represent the Debtor.

As the date of this tentative ruling, the Court has not received a response from Counsel or any opposition to the Motion. Pursuant to LBR 9013-1(h), failure to file a timely opposition may be deemed consent to the granting of the Motion.

Findings of Fact and Conclusions of Law

Bankruptcy Code § 329(a) requires any attorney representing a debtor to file a statement of compensation received. 11 U.S.C. § 329(a). Section 329(b) provides that “[i]f such compensation exceeds the reasonable value of any such services, the court may cancel any such agreement, or order the return of any such payment, to the extent excessive, to the entity that made such payment.” FRBP 2017(a), which implements § 329(a), further provides:

On motion by any party in interest or on the court’s own initiative, the court after notice and a hearing may determine whether any payment of money or any transfer of property by the debtor, made directly or indirectly and in contemplation of the filing of a petition under the Code . . . to an attorney for services rendered or to be rendered is excessive.

The burden of proof is on the applicant for all issues arising under § 329. *In re Rheuban*, 121 B.R. 368, 383 (Bankr. C.D. Cal. 1990) (citing *In re Swartout*, 20 Bankr. 102, 105 (Bankr. S.D. Ohio 1982)).

As noted above, Counsel has not filed an opposition to the UST's Motion. The Court finds that Counsel has not met his burden to prove the reasonableness of his services. Further, Counsel's services provided in this case were incomplete and gave little benefit to Debtor. Even after a deficiency notice from the Court, Counsel failed to file required documents within the requisite 72-hour period, resulting in dismissal of Debtor's case. Based on the foregoing, the Court finds that the Counsel failed to show the reasonableness of the fees collected.

Accordingly, the Motion is GRANTED. The Counsel is ordered to disgorge all fees collected from the Debtor.

The UST shall lodge a confirming order within 7 days of the hearing.
