The Chapter 13 Trustee has failed to make a sufficient showing that this case should be dismissed on grounds of bad faith filing and failure to timely file required documents. The filing of a bare bones petition does not automatically establish bad faith. Here, the emergency arose because Debtors were on the verge of losing occupancy of their family home pursuant to a writ of possession. The Court recognizes preservation of the family homestead as a valid emergency permitting a bare bones filing.

Although certain case commencement documents were filed late, they were filed only approximately one week late, and Debtors have explained the late filing by reference to the date of their receipt of the Court order extending the time to file documents.

Regarding the late filing of documents, there is not one rule for attorneys and one rule for everyone else. Like all other people, attorneys are susceptible to physical illness, family emergencies, etc. and other events that can justify late filing. The Court declines the Chapter 13 Trustee's invitation to hold the Johnsons to a higher standard merely because one of the two spouses is an attorney.

The Chapter 13 plan has now been filed, as have most of the other documents referenced in the motion.

The motion is denied without prejudice. The Debtors are cautioned that additional delinquencies in this case may lead to a different result if the chapter 13 trustee presents another motion to dismiss to the Court.
