Tentative Ruling:

Elizabeth F. Rojas, chapter 13 trustee (“Trustee”) filed this motion to dismiss pursuant to § 1307(c)(6) due to a material default with respect to the Debtor’s confirmed plan. Trustee gave notice of opportunity to request a hearing pursuant to LBR 3015-1(w) and 9013-1(o). Debtor has filed a response requesting a hearing and stating that the alleged default, including but not limited to any delinquency in plan payments, will be cured within reasonable time. **Appearances are required.**

The motion is granted. Section 1307(c) provides, in pertinent part, that the court may convert a case under chapter 13 to a case under chapter 7, or may dismiss a case under chapter 13, whichever is in the best interests of creditors and the estate, for cause, including a material default by the debtor with respect to a confirmed plan. 11 U.S.C. § 1307(c)(6). The failure to make timely payments under a confirmed chapter 13 plan is cause for dismissal under § 1307(c)(6). *See Sievers v. Green (In re Green)*, 64 B.R. 530, 531 (9th Cir. BAP 1986) (holding that a delinquency in plan payments is grounds for dismissal).

Based upon the evidence presented, the court finds “cause for dismissal under § 1307(c)(6) due to the debtor’s failure to make timely payments to the Trustee in accordance with the confirmed plan; and further, that dismissal of the case would be in the best interests of creditors and the estate. Debtor has filed a motion seeking a modification of the plan or suspension of plan payments pursuant to LBR 3015-1(n) & (w), but the trustee opposes the motion and debtor has failed to properly notice the matter for hearing. Absent payment of the delinquent installments due under the Debtor’s confirmed plan at or before the date of the hearing, the case will be dismissed.

Final Ruling. This valuation motion has been set for hearing on the notice required by LBR 9013-1(d)(2). The failure of the trustee and other parties in interest to file written opposition at least 14 days prior to the hearing as required by LBR 9013-1(f) is considered as consent to the granting of the motion. LBR 9013-1(h). *Cf. Ghazali v. Moran*, 46 F.3d 52, 53 (9th Cir. 1995). Further, because the court is granting the relief requested by the moving party and for which a *prima facie* case has been established, an actual hearing is not necessary. *See Boone v. Burk (In re Eliapo)*, 468 F.3d 592, 602 (9th Cir. 2006). Their defaults are entered and the matter will be resolved without oral argument. LBR 9013-1(j)(3). **No appearance is necessary.**

Debtor seeks to value the debtor's residence at a fair market value of \$520,000.00. The evidence supports a finding that the subject property had a value of \$520,000.00 as of the date of the petition and the effective date of the plan. *See, e.g., BAC Home Loans Servicing, LP v. Abdelgadir (In re Abdelgadir)*, 455 B.R. 896, 903 (9th Cir. BAP 2011) ("[T]he determinative date for whether a claim is secured by a debtor's principal residence is, like all claims, fixed at the petition date."); *Benafel v. One West Bank, FSB (In re Benafel)*, 461 B.R. 581, 587 (9th Cir. BAP 2011) (adopting the rule in *Abdelgadir*, but recognizing as a correct approach the valuation of a secured creditor's claim at confirmation). The subject property is encumbered by a first deed of trust lien held by Select Portfolio Servicing, Inc., securing a loan with a balance as of the petition date of approximately \$574,907.71. Therefore, Specialized Loan Servicing, LLC's claim secured by a junior deed of trust lien is completely under-collateralized. No portion of this claim will be allowed as a secured claim. *See* 11 U.S.C. § 506(a).

The fact that the junior lienholder's claim is secured only by a security interest

in the debtor's principal residence does not prohibit modification. Zimmer v. PSB Lending Corp. (In re Zimmer), 313 F.3d 1220, 1227 (9th Cir. 2002); Lam v. Investors Thrift (In re Lam), 211 B.R. 36, 41 (9th Cir. BAP 1997), *appeal dismissed*, 192 F.3d 1309 (9th Cir. 1999). Furthermore, no interest need be paid on the junior lienholder's wholly unsecured claim except to the extent otherwise required by 11 U.S.C. § 1325(a)(4).

Valuing the junior lienholder's security and providing the above treatment does not violate In re Hobdy, 130 B.R. 318 (9th Cir. BAP 1991). The plan is not an objection to the junior lienholder's proof of claim pursuant to 11 U.S.C. § 502 and FRBP 3007. The plan makes provision for the treatment of the claim and all other claims, and a separate valuation motion has been filed and served in accordance with 11 U.S.C. § 506(a) and FRBP 3012. In addition to serving the plan on all creditors, debtor served the motion to value collateral with a notice that the collateral for the junior lienholder's claim would be valued. The valuation motion is supported by evidence as to the value of the subject property. The content of the notice meets the due process requirement that it be "reasonably calculated, under all of the circumstances, to apprise interested parties of the pendency of the action and to afford them the opportunity to present their objections." Mullane v. Central Hanover Bank & Trust Co., 339 U.S. 306, 314 (1950).

Valuation pursuant to 11 U.S.C. § 506(a) and FRBP 3012 is a contested matter initiated by the filing of a motion. FRBP 3012. Valuation does not require the filing of an adversary proceeding. Scott v. Countrywide Home Loans, Inc. (In re Scott), 376 B.R. 285, 291 (Bankr. D. Idaho 2007). Even if considered in the nature of a claim objection, an adversary proceeding is not required. FRBP 3007. The valuation motion does not seek to avoid the lien nor determine the extent, validity, or priority of the security interest. *See* FRBP 7001(2). The court is not determining the validity of a claim or avoiding a lien or security interest. The junior lienholder's deed of trust will remain of record until the plan is completed. 11 U.S.C. § 1325(a)(5)(B)(i).

To the extent that valuation is based on evidence in the form of the debtor's declaration, the debtor may testify regarding the value of property owned by the debtor. Fed. R. Evid. 701; *see* So. Central Livestock Dealers, Inc. v. Security State Bank, 644 F.2d 1056, 1061 (5th Cir. 1980). Given the absence of evidence to the contrary, the debtor's opinion of value is conclusive. *See* Enewally v. Washington
