Tentative Ruling:

Tentative for 9/29/21 is to DENY without prejudice.

Movants seek relief from stay (and annulment) to proceed with a pre-petition state court action alleging fraud and other claims against Defendants. Movants who have not filed an adversary proceeding related to this action at this time argue that the debt would be nondischargeable pursuant to Section 523(a)(2)(A). Defendants oppose the motion, asserting that this matter can and should be determined in bankruptcy court.

The party moving for relief from stay bears the burden of establishing that cause exists for such stay relief. *LaPierre v. Advanced Med. Spa Inc.* (*In re Advanced Med. Spa Inc.*), Nos. EC-16-1087, 15-27456-B-7, 2016 Bankr. LEXIS 2205, at *9 (B.A.P. 9th Cir. May 23, 2016). Courts routinely weight multiple "factors" in order to determine if cause exists to allow the litigation to proceed in another forum. See *Truebro, Inc. v. Plumberex Specialty Products, Inc.* (*In re Plumberex Specialty Products, Inc.*), 311 B.R. 551, 559 (Bankr. C.D. Cal. 2004).

Movants' motion contains no analysis or showing of the aforementioned *Plumberex* factors. Moreover, the supporting declaration lacks foundation and personal knowledge. Therefore, Movants have not met their burden to

demonstrate that stay relief is warranted and the Court is inclined to DENY Movants' request.

As to the issue of annulment, bankruptcy courts typically consider multiple factors, including the debtor's overall good faith under a totality of the circumstances; whether the creditor was aware of the stay but nonetheless took action; how quickly the creditor moved for annulment; whether, after learning of the bankruptcy, the creditor proceeded to take steps in continued violation of the stay, or whether it moved expeditiously to gain relief; and the extent of prejudice to creditors or third parties if the stay relief is not made retroactive. *In re Sinclair*, 2013 WL 2303729 (BAP 9th Cir. 2013).

Movants' motion is devoid of any details regarding why annulment is required, and likewise lacks any analysis of the foregoing legal factors. Therefore, the Court is inclined to DENY the request for annulment.

On April 17, 2020, the United States Bankruptcy Court entered an order imposing \$62,172.86 in sanctions against Lora Steinmann in connection with a motion to compel ("Sanctions Order") [Bk. Dkt. No. 848]. That sanction amount was promptly paid, and the Sanctions Order was timely appealed on or about December 2, 2020. The Sanctions Order has been vacated twice, first on March 26, 2021 [USDC Case no. 8:20-cv-02272-RGK, Dkt. No. 15; Bk Dkt. No.1077] ("The Court VACATES and REMANDS the bankruptcy court's award of attorney fees") and again on June 2, 2021, the District Court amplified its vacation of the entire award [USDC Case no. 8:20-cv-02272-RGK, Dkt. No. 16; Bk. Dkt. 1132]. Not only did the District Court vacate the entire sanctions award, but it also required this Court to determine if sanctions were appropriate or not.

This motion is GRANTED and appearances are excused.

On August 16, 2021, Plaintiffs filed their motion for summary judgment against Defendant, asserting that Defendant engaged in willful and malicious conduct causing damages to Plaintiffs and that those damages are non-dischargeable under 11 U.S.C. §523(a)(6). Defendant did not file an opposition. For the reasons more fully stated below, the Court will grant summary judgment in favor of Plaintiffs in the amount of \$373,352.00, along with costs to be determined through submission of a bill of costs.

To be entitled to the relief requested, Plaintiffs must establish that there is "no genuine dispute as to any material fact and that Movant is entitled to judgment as a matter of law." FRCP 56. Plaintiffs assert that there is no genuine dispute of material fact that Defendant willfully and maliciously infringed on Plaintiffs' trademarks after ceasing to make payments under their franchise agreement but continuing to publicly use the trademarks for the purpose of exploiting the goodwill associated with the trademarks. This Court agrees.

§523(a)(6) provides that an individual may not discharge a debt for willful and malicious injury to another entity. *In re Su*, 290 F.3d 1140, 1142 (9th Cir. 2002).

To satisfy the willful injury requirement, Plaintiffs must show either that Defendant had a "subjective motive to inflict the injury" or Defendant "believe[d] that injury [wa]s *substantially certain* to occur as a result of his own conduct." *In re Su*, 290 F.3d 1140, 1142 (9th Cir. 2002) (emphasis added). In evaluating what Defendant may have believed at the time of the action, the court may consider circumstantial evidence. *Id.* at 1146, fn 6. Further, the Court may charge a debtor "with the knowledge of the natural consequences of his actions." *Ormsby v. First Am. Title Co.* (*In re Ormsby*), 591 F.3d 1199, 1203 (9th Cir. 2010) (where the court found from circumstantial evidence that a debtor must have been aware that injury to creditor was substantially certain to result from his misappropriation of creditor's assets because he had previously paid that creditor for access to the misappropriated assets).

To satisfy the malicious injury requirement, there must be: (1) a wrongful act; (2) done intentionally; (3) which necessarily causes injury; and (4) is done without just cause or excuse. *Id.* "[I]ntentional infringement is tantamount to intentional injury under [§ 523(a)(6)]." *In re Smith*, No. ADV.01-02219-A, 2009 Bankr. LEXIS 4582, 2009 WL 7809005, at *9 (B.A.P. 9th Cir. Dec. 17, 2009) aff'd, 465 F. App'x 707 (9th Cir. 2012) (unpublished).

Here, Plaintiffs have provided evidence demonstrating that Defendant was aware of the value of Plaintiffs' trademarks, continued to use Plaintiffs' trademarks (in direct violation of his written agreements with Plaintiffs) after he was no longer making payments to Plaintiffs and after being formally advised to discontinue use, and that Plaintiffs were thusly deprived of proper compensation for the use of their trademarks. In so showing, Plaintiffs have met their burden to demonstrate Debtor's willfulness and maliciousness.

As to damages, when asserting a cause of action for intentional infringement, "a plaintiff shall be entitled . . . to recover (1) defendant's profits, (2) any damages sustained by the plaintiff, and (3) the costs of the action." 15 U.S.C. § 1117(a). Plaintiffs have provided evidence supporting their entitlement to damages in the amount of \$373,352.00, exclusive of costs.

Therefore, the Court will enter summary judgment in favor of Plaintiffs in the amount of \$373,352.00, along with costs to be determined through submission of a bill of costs. Plaintiffs shall submit a bill of costs not later than
