No opposition was filed.

The debtor's objection to proof of claim ("Claim No. 4") filed with the court's Claims Register by White & Whitley Group, LLC ("Claimant") is SUSTAINED. The failure of the creditor to file written opposition at least 14 days prior to the hearing as required by LBR 9013-1(h) is considered as consent to the sustaining of the objection. LBR 9013-1(h). Cf. Ghazali v. Moran, 46 F.3d 52, 53 (9th Cir. 1995). Further, the debtor has established a *prima facie* case for granting the relief requested. **Appearances waived.**

The objection is sustained. The Court disallows Claim No. 4 as a proof of claim that lacks the documentation required by Rule 3001(c) does not qualify for the evidentiary benefit of Rule 3001(f)--it is not *prima facie* evidence of the validity and amount of the claim. Here, debtor contends that the amount asserted in the claim is not owed. Further, there is no evidence that Claimant is the successor in interest to CashCall, Inc., and; therefore, Claimant lacks standing to file a proof of claim in this case. The objecting party shall submit an appropriate order granting the relief requested pursuant to this tentative ruling.
