**Tentative Ruling:**

No opposition was filed.

This objection to the proof of claim of Schools Federal Credit Union ("Claim No. 14") has been set for hearing on at least 30 days' notice to the claimant as required by FRBP 3007 and LBR 3007-1. The failure of the claimant to file written opposition at least 14 days prior to the hearing as required by LBR 3007-1(b)(6) is considered as consent to the sustaining of the objection. See LBR 9013-1(h). Ghazali v. Moran, 46 F.3d 52, 53 (9th Cir. 1995).

The court is granting the relief requested to disallow Claim No. 14. The claimant's default is entered and the matter will be resolved without oral argument. LBR 9013-1(j)(3). **Appearances waived.**

The objection is sustained. The court disallows Claim No. 14 as it was not timely filed. Claim No. 14 was filed on October 30, 2020, after the deadline of October 16, 2020 for filing claims in this case. The objecting party shall submit an appropriate order granting the relief requested pursuant to this tentative ruling.
