Tentative Ruling for February 5, 2026:

Plan says on page 5 that unsecured creditors will share \$53,400. Why does the confirmation brief say on page 7 at line 26 that they will share \$36,000? Court will not reduce the amount that creditors were told in the plan that they would receive. Moreover, it appears from page 2 of the plan that the debtor is simply planning to pay unsecured creditors disposable income, which the debtor has valued at \$53,400, as if this is an estimated amount. But on page 5 of the plan, the debtor promises to pay unsecureds an aggregate of \$53,400 over 36 months. In order to monitor debtor's compliance with the plan and ensure that unsecured creditors will receive at least the small percentage of distribution contemplated by the plan (approximately 4.9 percent) (and in light of the fact that class 4 has voted to reject the plan), court will interpret the treatment section of the plan (as distinguished from the introductory sections) as binding. Debtor will be understood to have committed to pay unsecured creditors this amount.

The brief makes reference to a limited opposition from the subchapter V trustee (on page 6 at line 16), which the brief says is addressed below, but isn't. The docket does not reflect the filing of an objection, limited or otherwise. Is this correct?

Final Ruling for November 19, 2025:

Continue status conference to December 10, 2025 at 2:00 p.m. so that the Court can review revised plan. Debtor should file amended plan not later than December 5, 2025.

Tentative Ruling for December 10, 2025:

Ask debtor to make a few additional modifications to the latest version of the plan and then set schedule for confirmation hearing. Continue case status conference to same date and time as confirmation hearing.
