Tentative Ruling for February 10, 2022:

Grant motion. Find Mr. Ramon in (civil) contempt for failing to file monthly declarations on November 1, December 1 and January 1 and impose sanctions of \$50 per day (up to a maximum of 30 days) to induce compliance. Discuss next steps with US Trustee if additional sanctions prove ineffective.

Final Ruling for February 10, 2022:

Respondent appeared and court explained that declarations should be filed even if required payments have not been made. Respondent brought money orders for partial payment. Court instructed respondent to send payments that were to be made to the debtors to the debtors and payments that were to be made to the U.S. Trustee to the U.S. Trustee. (Court recommended that registered mail be used or some other means of transmission that will permit

respondent to determine whether payments were actually delivered.) Court continued hearing to give respondent an opportunity to make payments and file missing declarations.

Tentative Ruling for March 2, 2022:

Docket does not reflect the filing of any declarations. Tentative ruling from February 10, 2022 remains unchanged.

Tentative Ruling for July 13, 2022:

Court has received one declaration attesting to the fact that one payment for \$150 has been paid for the month of May this year. Why haven't any additional declarations been filed? Hearing required.

Final Ruling for July 13, 2022:

See written order entered July 21, 2022. Respondent held in contempt for failing to file declarations. Respondent sanctioned \$50 per day commencing on August 8, 2022 and continuing for up to 30 days until he files declarations due June 1, July 1 and August 1, 2022. Court set continued hearing for August 17, 2022 at 11:00 am. Order provides that court will issue bench warrant if respondent fails to attend the August 17 hearing.

Tentative Ruling for August 17, 2022:

Respondent filed a declaration on August 2, 2022 declaring that he is sending \$150 to the debtors for the months of June and July 2022. He attached an exhibit with a photocopy of 2 postal money orders, each for \$150. Declaration also explains that he did not file declarations because he was not working and did not have money to send to the debtor. Debtor should file declarations every month even if he is not sending money at the same time.

Debtor also filed a declaration on August 8, 2022, attesting to the fact that he is sending the debtors an additional \$125 for the month of August, 2022.

the debtors, it appears that the respondent has purged his contempt pursuant to the Court's July 21, 2022 order.

If respondent appears, discuss with parties where we go from here.

Final Ruling for August 17, 2022:

Court found that respondent had purged the civil contempt sanction set forth in the court's July 21, 2022 order. US Trustee will lodge order providing that, if respondent fails to file the required declarations when due for September, October and November, commencing on the 8th day of the month following the filing due date of the required declaration and continuing each day for a period not to exceed 30 days, respondent shall be sanctioned \$50 per day for not filing the declaration. (Once sanction reaches \$1,500, no further sanctions will be imposed for these particular declarations.) Court continued hearing to December 14, 2022 at 11:00 a.m. to see if respondent complies with new order and whether additional sanctions are necessary to ensure that respondent continues to comply with court's October 1, 2021 order.

Tentative Ruling for December 14, 2022:

Respondent has filed monthly declarations, albeit all of them late. The September declaration was filed on September 8, 2022. The October declaration was filed on October 14, 2022. The November declaration was filed on November 14, 2022. Under the terms of the August 24 order, according to the Court's calculations, sanctions should be due for 12 days at \$50 per day, or \$600.
