## **Tentative Ruling:**

Other than filing a motion to continue this hearing to give her yet more time to find counsel, the debtor's principal has not responded to this OSC. As the Court has previously explained, the debtor's principal has demonstrated a clear pattern of filing bankruptcy cases that she does not intend to prosecute in order to obtain the benefit of the automatic stay. This is abuse of the bankruptcy process and must not be permitted to continue.

Enter order prohibiting debtor from filing bankruptcy for a period of 5 years and prohibiting debtor's managing member, Anne Kihagi, from filing bankruptcy under any chapter of the bankruptcy code for herself or any entity in which she owns an interest for a period of 5 years.
