(US Bank's objection was not supported by a declaration and the service copy delivered to Judge Bluebond was two-sided.)

Is the plan feasible? Court understands that the debtor's mother will be providing the funds necessary to pay creditors' claims, but section 1129(a) (11) also requires that the Court find that confirmation is not likely to be followed by the need for liquidation or further financial reorganization of the debtor unless such liquidation or reorganization is proposed in the plan. Debtor represents that her monthly expenses exceed her income by more than \$9,000 per month and there is nothing in the plan about how this shortfall will be addressed. The debtor apparently intends to continue spending approximately \$35,000 per month on living expenses even though she takes in approximately \$26,000 per month. The projections of disposable income attached as Exhibit E reflect an increasingly large negative balance at the end of each year. How will this work? What is the debtor's game plan? The plan does not appear to solve the debtor's financial problems.

Moreover, can it be said that the plan has been proposed in good faith if the debtor is only making a distribution of 4.1 percent on account of her

unsecured claims yet is continuing to live a relatively lavish life style? How much disposable income would she have if she reduced her expenses to more reasonable amounts? And LCF Group raises what appear to be legitimate issues concerning the debtor's valuation of her assets. It is true that an owner is *permitted* to offer testimony concerning the value or property she owns, but how persuasive is this testimony? Are there any appraisals of any of the real properties?

The plan does appear to provide for a cure of all arrearages on the claim secured by the debtor's principal residence by the effective date, so there is no inappropriate modification of this secured claim. Court agrees with the debtor that there is no inappropriate gerrymandering. The debtor is proceeding with a nonconsensual confirmation and need not rely on the affirmative vote of any class in favor of confirmation. Moreover, the plan is fair and equitable and does not discriminate unfairly in that both classes 2A and 2B receive the same treatment and share a pro rata distribution of the same lump sum.
