#### Basis for Tentative Ruling

1. Debtor failed to file a confirmation brief in support of the Third Amended Plan (TAP). Incredibly, Debtor's counsel, who has appeared before this court on chapter 11 matters for many years, take the position that the August 30, 2021 Order did not require a confirmation brief for the operative plan. The confirmation brief filed five months ago on May 27, 2021 is patently insufficient for an amended plan filed September 16, 2021. Indeed, the information set forth in the May 27, 2021 confirmation order is likely stale. Further, the declaration of Donna Beck and her financial projections attached to the September 16, 2021 Third Amended Plan is dated February 26, 2021, *eight months ago*.

2. Debtor appears to assume that the value of the property securing ASB's lien is \$250,000 but provides *no evidence* re the same. Similarly, Debtor disputes that validity of the lien but has taken no steps to seek such a determination. Debtor even suggests that this court will make findings in this regard at the confirmation hearing --- without a proper motion or evidence.

3. The court agrees with the analysis set forth in ASB's opposition at pp. 6 - 10 that Debtor has not satisfied the requirements of 1129(a)(7)(A)(ii) or 1129(b)(2)(A).
