**Ruling for June 8, 2022:**

Plaintiff seeks a determination that a state court judgment in Plaintiff's favor against the debtor, Jeff Aronson, and Olympia Financial Mortgage, Inc. for \$534,385 is non-dischargeable under sections 523(a)(2), (a)(4) and (a)(6) of the Bankruptcy Code. On May 26, 2022, Plaintiff filed a motion for default judgment (the "Motion") which fails to provide any legal authority or analysis demonstrating that the allegations of Plaintiff's complaint entitle Plaintiff to a judgment under section 523(a)(2), (a)(4) or (a)(6). Judge Barash's "Judicial Variance Statement" posted on the Court's website expressly states as follows:

LBR 7055-1(b) Motions for Default Judgment: In addition to evidence of the amount of damages, plaintiff must submit admissible evidence to establish all elements of the plaintiff's claim(s) for relief.

Plaintiff's Motion fails to include any evidence in support of any of the material allegations of the complaint.
