It appears that most of the objections to the disclosure statement have been ameliorated by revisions to the disclosure statement, or raise plan confirmation issues that are more appropriately considered at the confirmation hearing.

However, the Court does not believe it is appropriate to approve a disclosure statement, permit solicitation, and schedule a confirmation hearing where the debtor has not yet noticed a claims bar date. Although the debtor may feel confident that it knows who its creditors are and for what amounts, the bar date noticing process is intended to test the debtor's assumptions in that regard and provide potential creditors due process.

Further, the Court is not persuaded that "adequate information" is being provided about the plan if there are material parts of the plan that have been intentionally omitted. It appears that the debtor intends to supplement the plan shortly before the confirmation hearing, but after the solicitation process. The court is familiar with this practice, but does not believe it is a sound one, at least not in every circumstance. Here, the Court does not know what the debtor intends to do with any plan supplement and is not persuaded that it is appropriate here.

Accordingly, the Court is inclined to set a bar date, order the debtor to notice parties in interest regarding the bar date, continue the hearing on the present motion, and provide the debtor an opportunity to further supplement and revise its plan and disclosure statement after the expiration of the bar date.
