- b. The legal elements that each party is required to establish for the Court to find that the Debtor is a responsible person of Alpha Omega?
 - c. What is the standard of proof required on those elements? Preponderance of the evidence? Clear and convincing?
 - d. What are the legal authorities that support the parties' positions on these issues?
2. Clearly the parties dispute the proper amount of the tax owed. Do the parties agree on the following, and if not, where do they agree?
 - a. Who bears the burden of proof on the amount of the tax owed?
 - b. Is that burden a shifting burden? If so, how does that work?
 - c. What is the standard of proof? Preponderance of the evidence? Clear and convincing?
 - d. What are the legal authorities that support the parties' positions on these issues?
3. Is Alpha Omega the only corporate taxpayer at issue or is there a dispute between the parties regarding whether a portion of the proof of claim is based on sales by Equiptool Inc.? If so, will whether Dtr is a "responsible person" of Equiptool be one of the issues at issue at trial?
4. CDTFa asserts in its briefs that Cal. Rev & Tax Code § 6481 governs what it is allowed to use as records to calculate a tax. That section provides:

If the board is not satisfied with the return or returns of the tax or the amount of tax, or other amount, required to be paid to the state by any person, it may compute and determine the amount required to be paid upon the basis of the facts contained in the return or returns or upon the basis of any information within its possession or that may come into its possession.

Does the Debtor stipulate that this is the relevant law governing this issue? If not, the Debtor will need to brief the contrary legal authorities and the legal authorities in favor of whatever the Debtor contends are the appropriate source documents to calculate the tax.

Debtors' Motion for Summary Judgment challenges the validity and enforceability of Central Bank's proof of claim number 1 (the "Claim"). The Claim is based on a January 20, 2021 "Partial Summary Judgment, Judgment on the Pleadings, and Order of Sale" with a monetary award for \$358,412.72 in favor of Central Bank, and against Debtors, entered by a Kentucky state court (the "Kentucky Judgment"). Pursuant to a March 7, 2024, Kentucky state court order, the amount of the Claim was reduced by \$66,884.60, which is the amount of foreclosure sale proceeds the Kentucky trial court ordered to be distributed to Central Bank on account of its junior lien. "Under the Full Faith and Credit Act, 28 U.S.C. § 1738, the preclusive effect of a state court judgment in a subsequent bankruptcy proceeding is determined by the preclusion law of the state in which the judgment was issued." *Harmon v. Kobrin (In re Harmon)*, 250 F.3d 1240, 1245 (9th Cir. 2001). Thus, the preclusive effect of the Kentucky Judgment is determined by Kentucky preclusion law.

Central Bank's opposition to the Motion for Summary Judgment does not brief Kentucky preclusion law. The hearing is continued to January 29, 2026, at 2:30 p.m. No later than January 8, 2026, Central Bank shall file a supplemental brief addressing the elements of Kentucky preclusion law and briefing whether this Court is bound by the Kentucky Judgment. On October 15, 2025, the Debtor filed a *Status Report for Initial Scheduling and Case Management Conference* (the "Status Report"). Case Dkt. 38.

In order for the Debtor to address the issues identified below, the Court will continue the status conference to **1:30 p.m. on November 18, 2025**.

A. Debtor's Budget

The Status Report offers the following regarding the Debtor's projected income, expenses, and cash flow:

The 336 Hillcrest Property generates \$3,634.61 in monthly rents from the cell tower lease with T-Mobile USA, Inc. Debtor intends to utilize the rents together with the funds on deposit in Debtor's checking account at [Royal Business Bank], totaling \$260,145.85, to fund its monthly expenses projected to be approximately \$21,000 per month.

Id. at p. 8. In contravention of the Order, these statements are not supported by any evidence. In fact, the record contains evidence that tends to undermine these statements; the Debtor's schedule A/B discloses that the value of the Debtor's interest in cash on deposit at Royal Business Bank ("RBB") is "unknown." Case Dkt. 18. The Status Report states elsewhere that the Debtor has been unable to close its account with RBB due to an ongoing dispute with RBB regarding contractual limitations on the use of such funds, and that RBB "has been unwilling to turnover the funds in the account to [the Debtor]." Case Dkt. 38, at p. 5.

No later than November 7, 2025, the Debtor must file and serve an amended status report that: (1) breaks out the Debtor's projected monthly expenses, (2) contains a comparison to actual results for the 12 months preceding the filing of the case, and (3) is supported by evidence.
