To obtain relief under section 362(d)(4) of the Bankruptcy Code, Local Bankruptcy Rule 4001-1(c)(1)(B) and the Order Shortening Time for this hearing (case dkt. 14) require the motion and all evidence in support thereof to be served on the "original borrower," Jose Fuentes Construction, Inc. Movant's *Notice* filed on February 11, 2025, indicates Movant served Jose Fuentes Construction, Inc. with written notice of the hearing and the Order Shortening Time but does not state that any of the moving papers were served. At the hearing, Movant shall be prepared to direct the Court to proof of such service.

Additionally, Movant prays for annulment of the automatic stay but fails to offer (i) any evidence of what Movant did following the petition date to require annulment and of when Movant learned about the filing of this case and (ii) briefing regarding the *Fjeldsted* factors for annulment.
