Ruling for November 19, 2025

Debtors' Motion for Summary Judgment challenges the validity and enforceability of Central Bank's proof of claim number 1 (the "Claim"). The Claim is based on a January 20, 2021 "Partial Summary Judgment, Judgment on the Pleadings, and Order of Sale" with a monetary award for \$358,412.72 in favor of Central Bank, and against Debtors, entered by a Kentucky state court (the "Kentucky Judgment"). Pursuant to a March 7, 2024, Kentucky state court order, the amount of the Claim was reduced by \$66,884.60, which is the amount of foreclosure sale proceeds the Kentucky trial court ordered to be distributed to Central Bank on account of its junior lien. "Under the Full Faith and Credit Act, 28 U.S.C. § 1738, the preclusive effect of a state court judgment in a subsequent bankruptcy proceeding is determined by the preclusion law of the state in which the judgment was issued." *Harmon v. Kobrin (In re Harmon)*, 250 F.3d 1240, 1245 (9th Cir. 2001). Thus, the preclusive effect of the Kentucky Judgment is determined by Kentucky preclusion law.

Central Bank's opposition to the Motion for Summary Judgment does not brief Kentucky preclusion law. The hearing is continued to January 29, 2026, at
