Service of the Debtors' Motion to Disallow POC#4 (the "Objection") filed by the Water and Power Community Credit Union (the "Credit Union") is defective for multiple reasons. Federal Rule of Bankruptcy Procedure 3007 requires the Objection to be served on a claimant addressed "to the person most recently designated on the claimant's original or amended proof of claim. . ." F.R.B.P. 3007(a)(2)(A). Proof of Claim #4 is signed by Joann T. Montanez, Assistant Manager but Debtor's proof of service indicates the Objection was only served by mail addressed to:

Additionally, the Credit Union is federally insured by the National Credit Union Administration. Federal Rule of Bankruptcy Procedure 3007 requires the objection to a claim of an insured depository institution to be served in the manner provided by Rule 7004(h). F.R.B.P. 3007(a)(2)(A)(ii). Federal Rule of Bankruptcy Procedure 7004(h) requires service by certified mail address to an officer of the institution. Debtors failed to serve the Objection in accordance with Rule 7004(h).

Substantively, the Debtors' Objection is not persuasive. The Debtors contend POC#4 is a duplicate of POC#3. Even a cursory review of the two proofs of claims reveals the proofs of claims are based on different debts. Proof of Claim #3 includes loan documents dated May 11, 2022, and asserts a claim amount of \$6,169.95. Proof of Claim #4 includes loan documents dated June 3, 2022, and asserts a claim amount of \$6,156.10. It is evident that POC#4 is not a duplicate of POC #3.

Proof of Claim #5-1 asserts a secured claim for \$8,131.45, secured by a 2019 Toyota Camry. The Debtors' do not object to the amount of the claim or its secured status, but instead contend that the "amount necessary to cure any default as of the date of the petition" is inaccurate because the amount listed is \$12,934.55, which is greater than the total claim amount. After the Debtors filed their objection, the Credit Union filed an amended claim (POC#5-2), which is identical to the original POC#5-1 except that the cure amount is left blank and the claim is signed by Laura Bastidas, as Credit Resolution
