Relief from stay, waiver of the 14-day stay and 180-day prospective relief: Movant has properly served the Motion to obtain this requested relief and has demonstrated it is entitled to the relief requested. The Court will enter an interim order on the Motion, including 180-day prospective relief as of the April 30, 2024, hearing date.

Section 362(d)(4) relief: Local Bankruptcy Rule 4001-1(c) requires all motions seeking relief under section 362(d)(4) to be served on "the person(s) who executed the documents through which the movant asserts its interest in the property (sometimes referred to in the

mortgage context as the 'original borrower' . . .)." LBR 4001-1(c)(1)(B). MRE Construction Group is the obligor under the promissory note in favor of Movant and the trustor under Movant's deed of trust. Case Dkt. 12 at ECF 73, 78, 83 94. Movant, however, did not serve the Motion on MRE Construction Group. To the extent Movant seeks relief under section 362(d)(4), the Court will continue the hearing on the Motion to May 28, 2024, at 2:30 p.m.

Relief from the co-debtor stay: Section 1301 provides the circumstances under which the automatic stay enjoins actions against a co-debtor of a chapter 13 debtor. Section 1301 only applies in chapter 13 cases and does not apply in chapter 7 cases, such as this case. Accordingly, the Court will deny Movant's request for relief from the co-debtor stay.
