The Court sets the following plan confirmation schedule:

1/24/25 - Debtor to serve notice of the confirmation hearing, objection deadline and solicitation packages

2/21/25 - deadline for counsel for the Debtor to receive ballots

2/21/25 - deadline for objections to confirmation however objecting parties are not required to include expert witness reports or declarations in support of their objection

**2/28/25 @ 10:00 a.m.** - the Court will hold a status conference on plan confirmation, including whether an expert witness discovery period is required. The Court will set deadlines for the Debtor to file its confirmation brief and evidence, and replies to any objections, at the 2/28/25 status conference on plan confirmation.
