A. Debtor's Budget

The Status Report offers the following regarding the Debtor's projected income, expenses, and cash flow:

The 336 Hillcrest Property generates \$3,634.61 in monthly rents from the cell tower lease with T-Mobile USA, Inc. Debtor intends to utilize the rents together with the funds on deposit in Debtor's checking account at [Royal Business Bank], totaling \$260,145.85, to fund its monthly expenses projected to be approximately \$21,000 per month.

Id. at p. 8. In contravention of the Order, these statements are not supported by any evidence. In fact, the record contains evidence that tends to undermine these statements; the Debtor's schedule A/B discloses that the value of the Debtor's interest in cash on deposit at Royal Business Bank ("RBB") is "unknown." Case Dkt. 18. The Status Report states elsewhere that the Debtor has been unable to close its account with RBB due to an ongoing dispute with RBB regarding contractual limitations on the use of such funds, and that RBB "has been unwilling to turnover the funds in the account to [the Debtor]." Case Dkt. 38, at p. 5.

No later than November 7, 2025, the Debtor must file and serve an amended status report that: (1) breaks out the Debtor's projected monthly expenses, (2) contains a comparison to actual results for the 12 months preceding the filing of the case, and (3) is supported by evidence.

The debtor seeks to employ Edgcomb Law Group as special counsel pursuant to Bankruptcy Code section 327(e) to represent it in Debtor's appeal of a Superior Court judgment and regarding compliance requirements related to an order of the Los Angeles Regional Water Quality Control Board that the debtor investigate and remediate environmental contaminants at the property.

Judgment creditors object, arguing that Edgcomb is disqualified because it is the recipient of a purportedly avoidable transfer. Postpetition, Edgcomb received a payment from debtor's insurer in respect of services that Edgcomb performed for the debtor prepetition. The judgment creditors contend this transfer is avoidable under Bankruptcy Code section 549 as an unauthorized postpetition transfer.

The Court does not find it necessary to determine whether (i) the funds received by Edgcomb constituted property of the debtor's estate or (ii) Edgcomb was the recipient of an avoidable transfer under section 549. Even if the Court assumes that the payment constituted an unauthorized postpetition transfer of estate property, Edgcomb would not be disqualified under section 327(e).

Section 327(e) provides:

The [debtor in possession], with the court's approval, may employ, for a specified special purpose, other than to represent the [debtor in possession] in conducting the case, an attorney that has represented the debtor, if in the best interest of the estate, and if such attorney does not represent or hold any interest adverse to the debtor or to the estate with

respect to the matter on which such attorney is to be employed.

11 U.S.C. § 327(e) (emphasis added); see 11 U.S.C. § 1107 (chapter 11 debtor in possession has rights and powers of trustee).

A professional employed as special counsel under section Bankruptcy Code section 327(e) need not be disinterested, as is required of a professional employed as general bankruptcy counsel under section 327(a). *Compare* 11 U.S.C. §327(a) *with* 11 U.S.C. §327(e); *see also* 11 U.S.C. 101(14). An estate may have claims against special counsel, or the special counsel may represent or hold an interest adverse to the estate, as long as it is not with respect to the matter on which the special counsel is to be employed.

The scope of Edgcomb's proposed employment is not to represent the debtor with respect to investigating and recovering avoidable transfers. Its employment would be limited to the aforementioned appeal and environmental compliance matters. In other words, the Court finds that Edgcomb does not represent any interest adverse to the debtor or to the estate with respect to the matter on which Edgcomb is to be employed. The Court also finds that the other prerequisites to employment under section 327(e) are satisfied.

The judgment creditors rely on two case authorities from the Ninth Circuit Bankruptcy Appellate Panel to support their objection, but the cases are inapposite. *See Movitz v. Baker (In re Triple Star Welding, Inc.)*, 324 B.R. 778, 794 (B.A.P. 9th Cir. 2005); *Coleman v. Hecker (In re Dexter Distrib. Corp.)*, 2010 Bank. LEXIS 5043, at 22 (B.A.P. 9th Cir. 2010). Both cases concerned counsel who could plausibly be defendants in preference actions brought by the debtor's estates. But both cases also involved general bankruptcy counsel under 327(a). Where is employed under section 327(a), the existence of an avoidance action against that counsel would render them not disinterested. The present circumstances are entirely distinguishable.
