# (1) Current issues

On 7/16/25, this Court entered an order approving bidding procedures (dkt. 331, the "Bidding Procedures Order") with respect to the sale of property located at 2420 South Western Avenue, Los Angeles, CA (the "Property"), and on 8/14/25, this Court entered an order amending certain of the deadlines set forth in the Bidding Procedures Order (see dkt. 336).

CONT... FAME Housing Corporation and Oner Charles Mergerson Chapter 7 are on file. Accordingly, the tentative ruling is to grant the Sale Motion (dkt. 340) in its entirety.

This Court has reviewed the declarations of David Thompson (dkt. 340, PDF pp. 26–27) and John Menchaca (dkt. 340, PDF pp. 22–25) filed in support of the request for a determination that the proposed purchaser, CIM Group Acquisitions LLC ("Purchaser"), qualifies as a "good faith" purchaser for purposes of 11 U.S.C. 363(m). The tentative ruling is that Purchaser is entitled to a good-faith finding under section 363(m).

<u>Proposed order(s)</u>: Unless otherwise ordered by this Court, Trustee is directed to lodge a proposed order via LOU within 7 days after the hearing date (per LBR 9021-1(b)(1)(B)).
