- (2) <u>Reasons</u>. (a) It appears appropriate to continue/impose the automatic stay, and to continue/impose it as to all persons rather than just as to selected persons, because one purpose of the automatic stay is to preventing a "race to collect" that could unfairly advantage some creditors at the expense of others. (b) To prevent possible abuse, this Court provides the foregoing simple process for reconsideration. See generally In re Rodriguez, case no. 2:25-bk-16676-NB, docket #25.
- (3) <u>Very limited ruling</u>. Analysis

Under 11 U.S.C. 726(a)(2)(C) (incorporated into this Chapter 13 case by 11 U.S.C. 502(b)(9)), a tardy claim must be allowed if the holder of the claim (i) "did not have notice or actual knowledge of the case in time for timely filing of [its] proof of claim ..." and (ii) a proof of claim is "filed in time to permit payment of such claim." Implementing this provision, Rule 3002(c)(7) (Fed. R. Bankr. P.) authorizes a court to permit an untimely proof of claim if "the court finds that the notice was insufficient to give the creditor a reasonable time to file [a proof of claim]."

The tentative ruling is that Movant has adequately demonstrated that it received insufficient notice of the claims bar date to give it a reasonable time to file a proof of claim. Movant has presented evidence that it was not aware of the claims bar date until after the deadline had passed and Debtor concedes that (x) Movant was not listed as a creditor prior to service of the

notice alerting creditors of the claims bar date, and (y) the address he subsequently supplied for Movant was inaccurate.

Debtor asserts that notice to Movant's prior <u>State Court</u> counsel, who allegedly was also representing Movant in a <u>different</u> bankruptcy case, was sufficient. But in general notice must be given to the creditor itself, or an <u>authorized</u> agent or other person who is found to have a duty to pass along the notice, not an attorney who represented the creditor for purposes other than the current bankruptcy case, and who most likely would have thought of any notice as a mere courtesy that was in addition to more formal notice to the client. *Cf. In re Villar*, 317 B.R. 88, 93-94 (9th Cir. BAP 2004) (service on State Court counsel insufficient). This Court cannot inquire into the attorney-client communications to make any exception for Debtor.

For all of the foregoing reasons, the tentative ruling is to extend the deadline for Movant to file a proof of claim to the date stated at the start of this tentative ruling.
