Discovery Motion Practice:

All discovery motions must be filed within 30 days of the service of an objection, answer, or response which becomes the subject of dispute or the passing of a discovery due date without response or production, and only after counsel have met and conferred and have reached an impasse with regard to the particular issue.

A failure to comply in this regard will result in a waiver of a party's discovery issue. Absent an order of the Court, no stipulation continuing or altering this requirement will be recognized by the Court.

Tentative Ruling:

The Court's tentative is to continue the status conference to **January 23, 2024, at 2 p.m.** for failure to file proof of service as required by the deadline set by this Court under Federal Rule of Civil Procedure 4(m). Plaintiff will also have to obtain a new Summons from the Clerk's Office, as the Summons & Complaint must be served on Defendant within 7 days. Proof of service indicates to the Court that the Defendant has notice that a complaint has been filed, and that Defendant will be expected to participate in this adversary proceeding.

After a plaintiff files an adversary proceeding, the Court will prepare and issue a summons. After the court places the summons on the adversary docket, it is the **Plaintiff's** responsibility to serve the Summons and Complaint on all defendants, and then file a proof of service with the addresses and methods used to provide service. **Service must be made by a person who is at least 18 years old and NOT a party to the complaint.**

****Plaintiff may not be the person who fills out and signs the *Proof of Service*****
