On March 25, 2025, Plaintiff's counsel informed the court Plaintiff needed additional time to comply with issues sets forth in the Court's March 25, 2025 tentative ruling for hearing on Plaintiff's motion for default. The March 25, 2025 hearing was then continued to May 6, 2025.

On April 30, 2025, the Court further continued the hearing on the motion for default to May 27, 2025, ADV Dkt. 50. At the May 27, 2025, hearing, no appearances were made by any of the parties to the adversary proceeding. Moreover, Plaintiff did not file any new documents addressing the Court's concerns raised in the March 25, 2025 tentative ruling.
