The Court's tentative ruling is to OVERRULE Chapter 13 Trustee's Motion to Disallow Debtor's Claim of Exemptions.

**Legal Analysis**

Trustee moves for an order disallowing Debtor's amended exemptions under C.C.P. § 704.100(c).

*C.C.P. § 704.100(c) Exemption*

Trustee's contention is that Debtor has not provided evidence to show that the life insurance benefits are reasonably necessary for her or her dependent's support. Debtor filed an Opposition and a Declaration in support, to address Trustee's objection.

Cal. Civil Procedure § 704.100(c) provides:

Benefits from matured life insurance policies (including endowment and annuity policies) are exempt to the extent **reasonably necessary for the support of the judgement debtor** and the spouse and dependents of the judgement debtor. *Rothery v. Daff (In re Rothery)*, 1998 U.S. App. LEXIS 8838, \*4-5 (9th Cir., May 1, 1998).(emphasis added) Whether the funds are "reasonably necessary" for the support of a debtor and dependents receiving them is a question of fact. *Id.* (emphasis added)

The bankruptcy court has wide discretion in deciding what amounts are reasonably necessary, taking into account the judgment debtor's present and future circumstances. *Spenler v. Siegel (In re Spenler)*, 212 B.R. 625, 631 (affirming bankruptcy court's determination under C.C.P. 704.115(e) that the funds in the debtor's IRA were not exempt because it was not "necessary to provide for the support of the judgment debtor). Courts have considered various factors including income, employment situation and prospects, retirement status, age, life expectancy, health, certainty of future financial status, budget, ability to regenerate retirement assets, tax obligations, and dependents' needs. *Welther v. Donell (In re Oakmore Ranch Mgmt.)*, 2005 Bankr. LEXIS 3409, \*10-11 (B.A.P. 9th Cir. 2005) *citing In re Moffat*, 119 B.R. 201, 206 (9th Cir. BAP 1990), *aff'd*, 959 F.2d 740 (9th Cir. 1992); *In re Switzer*, 146 B.R. 1, 5-6 (Bankr. C.D. Cal. 1992). "The ***California exemption statutes are liberally construed***, for their manifest purpose is to protect income and property needed for the subsistence of the judgment debtor." *In re Payne*, 323 B.R. 723, 727 (9th Cir. BAP 2005) (citation omitted)(emphasis added); *Schwartzman v. Wilshinsky*, 50 Cal. App. 4th 619, 630 (Cal.Ct.App. 1996) (***California exemption statutes should be construed to benefit the judgment debtor***).(emphasis added)

*Income*

At the time of Debtors' filing, most of Debtors' income was social security income of \$3,599 per month. Debtor's husband worked part-time as a golf shop attendant earning less than \$1,300 while Debtor walked dogs and rented a room in their home. Within a year, Debtor's husband has his income reduced to only \$637 per month.

On or about March 2020, the Covid-19 pandemic caused a further loss of income as Debtors' tenant moved out and Debtor's minimal dog-walking income ceased.

Passing away of Debtor's husband

In November of 2021, Debtor's husband was diagnosed with cancer and required to terminate his employment. Debtors then relied solely on their social security income and small pension of \$156 per month.

On or about December 22, 2023, Debtor's husband passed away losing his life to cancer and left Debtor devastated emotionally and financially. ECF doc. 84, Exhibit

A. Debtor was financially reduced to only the \$2,912.00 in social security income and \$156.33 in pension income ECF doc. 84, Exhibit B).

Debtor's income now totals only **\$3,068.33**—an amount well below the median income for a household of one. ECF doc. 83. Based on Debtor's monthly expenses of **\$4,382.98**, Debtor is still negative over \$900 per month. Thus, the insurance benefits are necessary to maintain her household expenses; and when they are exhausted in less 6 years, she will need to find additional support to maintain her increasing expenses.

*Employment situation and prospects*

Debtor's husband was 77 years old when he passed away. ECF doc. 84, Ex. A. Debtor did not disclose her age in her declaration, but it appears from the record that Debtor Susan is no longer in her prime earning years. Before her husband's death, Debtor worked part time as a golf shop attendant earning less than \$1,300 and walked dogs and rented a room in Debtor's home. Debtor's minimal dog-walking income terminated during the COVID-19 pandemic, and it is unclear whether Debtor can seek steady employment.

*Age*

Debtor's husband was 77 years old when he passed away. See . ECF doc. 84, Ex. A. Debtor did not disclose her age in her declaration, but it appears from the record that Debtor is no longer in her prime earning years.

*Life expectancy & Health*

Debtor's husband was 77 years old when he passed away. See . ECF doc. 84, Ex. A. Debtor did not disclose her age in her declaration and there is no information about her health status.

*Certainty of future financial status*

Debtor's future financial status appears difficult and uncertain. Debtor's spouse has also passed away making her financial future more challenging. When the insurance

benefits are exhausted in less 6 years, she will need to find additional support to maintain her increasing expenses.

*Budget & Dependent needs*

Debtor's income totaled only \$3,068.33, well below the median income for a household of one. Based on her monthly expenses of 4382.98, she is still ***negative over \$900 per month.***

Debtor's amended Sch. J, ECF doc. 83, shows reasonable expenses for a single woman. Debtor also explains that she exhausted approximately \$5,100.00 in funeral and other related costs after Debtor's husband passed away, as well as an unforeseen roof repair. Debtor explains that she has approximately \$71,744.00 left of the insurance proceeds to cover her living expenses. Debtor has no dependents.

Here, the evidence presented by Debtor, as viewed through the factors above, weigh in favor of finding that the life insurance policies proceeds are exempt as the funds are reasonably necessary for the support of Debtor Susan.
