The Court is inclined to continue the hearing to **November 16, 2022 at 11:00 am** to allow Debtor to provide evidence demonstrating the retail value of the Vehicle.

Joe Gene Archuleta, Jr. ("Debtor") moves this Court to value a 2013 Volkswagen Beetle Convertible ("Vehicle") secured by a loan held by Balboa Thrift and Loan Association ("Balboa"). The current balance of the lien is \$16,409.00. Debtors assert the value of the Vehicle is \$12,046.00 as of September 15, 2022. The Debtor requests the Court value the Vehicle at \$12,046.00.

11 U.S.C. § 506(a) governs the method of valuing secured claims in bankruptcy cases. *In re Morales*, 387 B.R. 36, 40 (Bankr. CD. Cal. 2008). The Supreme Court valued vehicles under a replacement value standard. *Assocs. Commercial Corp. v. Rash*, 520 U.S. 953, 959, fn. 2 (1997). The replacement value of a vehicle will generally equal its **retail value** less the value of warranties, inventory storage, reconditioning, and accessories. *Associates Comm'l Corp. v. Rash*, 520 U.S. at 965, fn. 6. (emphasis added) The retail value is calculated by adjusting the Kelley Blue Book or N.A.D.A. Guide retail value for a like vehicle in light of the condition, retail market, and other factors as of the petition date. *In re Morales*, 387 B.R. at 45, 47. And, the burden rests with debtor in proving the reasonableness of any deviation from the guide retail

value. *Id.* at 45. Evidence supporting an adjustment may be introduced by way of declaration, testimony, vehicle advertisements, expert or appraisal reports, and private party values, as appropriate. *Id.* at 46 (internal citations omitted).

Debtor's evidence does not support the retail value of the Vehicle.

Here, the Debtor has attached a copy of the Kelley Blue Book webpage valuing the Vehicle at a *trade-in* value of \$12,046.00 valid through September 15, 2022. *Morales* recognized the retail value as the appropriate starting point to determine the retail value of a vehicle. *Morales*, 464 B.R. at 46. Thus, Debtor's trade in valuation does not accurately capture the replacement price of the Vehicle under Section 506(a). Accordingly, the Court is inclined to continue the hearing to November 16, 2022 at 11:00 am to allow Debtor to provide evidence demonstrating the retail value of the Vehicle.
