Before the Court is *Subchapter V Trustee's Emergency Motion to Convert Case to Chapter 7* (the "Motion"). See Docket No. 261.

Pursuant to 11 U.S.C. §§ 1112(b)(1) and (4)(E) "on request of a party in interest, and after notice and a hearing, the court shall convert a case under this chapter to a case under chapter 7 or dismiss a case under this chapter, whichever is in the best interest of creditors and the estate, for cause," cause including "failure to comply with an order of the court."

On March 25, 2024, the Court entered that *Order After Hearing on Order To Show Cause: (1) Removing Debtor in Possession Pursuant to 11 U.S.C. § 1185; and (2) Invoking Duties of 11 U.S.C. §§ 1183(b)(5) and 1142(b) and Local Bankruptcy Rule 6004-1(c)(1) for the Subchapter V Trustee* (the "Order"). See Docket No. 254. Among other things, the Order provides that "[t]he Debtor shall not make any disbursements or transfers without the written authorization from the Trustee or her agent(s)." See *id.* at p. 3, lines 5-6.

The Motion provides that "the Debtor did not deposit March rent into the DIP Accounts and instead diverted those funds." See Docket No. 261, p. 4, lines 11-13. Of these amounts, \$20,000 remains outstanding and unaccounted for. See *id.* at p. 4, lines 18-20. On April 4, 2024, according to the Motion, "the Trustee informed the

Debtor and its counsel of \$4,750 in unauthorized expenditures that were made by the Debtor since the March 14, 2024 hearing on the OSC." *See id.* at pp. 4-5. The Motion provides that on or about April 13, 2024, "the Debtor caused two payments to be made to 'Mission Linen' totaling \$566.64," and that "[t]hese were not authorized payments and since the Debtor's operations are only renting food truck parking spaces at this time, there is no reason to be paying for linens." *See id.* at p. 5, lines 13-17.

All told, according to the Motion, "[t]he Debtor , without written authorization from the Trustee, has spent over \$50,000," in violation of the Order. *See* Docket No. 261, p. 2, lines 4-6.

The Court finds cause to convert the instant case to Chapter 7 pursuant to 11 U.S.C. § 1112(b)(1) for the Debtor's failure to comply with the Order. The Motion is granted. The Trustee is to upload a conforming order within 7 days.
