This matter is CONTINUED to February 17, 2026 at 10:00 a.m., with supplemental briefing due by 12:00 p.m. on February 9, 2026. Any oppositions to the Motion are due by 12:00 p.m. on February 13, 2026. The Motion presents several deficiencies which require further attention.

First, the docket does not reflect that Debtor properly served all interested parties. Although the supporting declarations assert that the majority of interested parties were served by electronic mail, the record does not establish that the recipients consented to electronic service as required by FRBP 7005.

Second, the Motion does not make the showing required for emergency relief. The Motion is largely conclusory and does not explain why immediate use of cash collateral is necessary to avoid irreparable harm. Neither the Motion nor the Omnibus Declaration [Dk. 6] identifies how much cash Debtor currently holds, and the Motion does not include the statement required by Rule 4001(b)(1)(B) or Form F-4001-2.

Third, the Motion misstates the scope of the SBA's collateral and the nature of cash collateral. The Motion incorrectly suggests that the absence of a deposit account control agreement eliminates the SBA's interest in proceeds and receivables, and it improperly conflates inventory and equipment with cash collateral.

Fourth, the proposed order appears to grant the SBA a superpriority administrative claim in addition to replacement liens, effectively converting prepetition debt into a postpetition superpriority obligation, rather than limiting adequate protection to protection against any demonstrated diminution in value.

Fifth, Debtor seeks authority to use cash collateral to pay a new bookkeeper for Chapter 11 services even though no application to employ that professional has been approved.

Finally, the financial exhibits attached to the Omnibus Declaration reflect multiple weeks of negative projected net operating cash flow and do not explain how projected shortfalls will be funded.

For these reasons, good cause exists to continue the hearing.

Second, although the Omnibus Declaration identifies Debtor's insiders and identifies certain "charges pending" that are owed to them, the Motion and Omnibus Declaration do not provide any further detail with respect to these payments within the context of the Motion. The Motion also does not identify which employees are owed wages, how much each is owed, or when those wages were last paid. Nor do the Motion or Omnibus Declaration identify Debtor's purported "critical vendors" or explain why any such vendors are considered critical.

Third, the Motion and Omnibus Declaration do not specify what payroll period Debtor seeks to pay or when the next payroll is due. Debtor also does not identify the payroll-related taxes or non-tax deductions at issue, or describe employee benefits, if any.

Second, Debtor seeks authority to pay monthly fees to Matt Dybing, CPA of Accounting Forward, for bookkeeping services related to this case, even though his employment has not been approved by the Court. In addition, the Motion and Omnibus Declaration do not clearly identify the amounts Debtor proposes to pay for those services.

Third, although the Motion is set to be heard concurrently with Debtor's cash-collateral motion, the Motion does not identify whether, or to what extent, the funds in the Bank of America account are subject to cash-collateral restrictions, or how the requested relief would operate in the event cash-collateral authority is limited or denied.

The Court is inclined to order Gregg Roberts to send a letter via certified mail to Debtor's affected family members with the proposed language in the Motion, but to deny in part as to the \$3,795.83 for five years of Lifelock identity theft protection for Debtor.

It appears undisputed that Mr. Roberts violated Fed. R. Bankr. P. 9037 and Local Rule 1002-1(d) by filing a Reply [Dk. 20] containing unredacted personal identifiers, such as the first five digits of Debtor's social security number and her month and year of birth, as well as the month and year of birth for 16 of Debtor's family members. Although the Reply was later restricted pursuant to the Court's Protective Order [Dk. 28], remedial relief is appropriate to address the risk created by the disclosure and the Court agrees that Debtor's proposed letter, as opposed to that of Mr. Roberts, will achieve this purpose.

The Court is inclined to DENY Debtor's request for \$3,795.83 in identity theft protection costs, as Debtor has not provided any evidence that Debtor has already purchased such protection nor is there any discussion in Debtor's Motion of other potential identity protection services.

The parties should appear and be prepared to address the foregoing.
