**Tentative Ruling:**

Tentative for 3/5/26:

Trustee seeks authority under 11 U.S.C. § 363(b) to form a wholly estate-owned limited liability company and, if the Estate acquires title through the noticed foreclosure sale, to transfer the Property at 387 and 391 40th Street, Oakland, California, into that entity. Trustee's stated objective is to limit potential administrative exposure associated with foreclosing upon and taking title to a partially constructed and distressed property.

The proposed LLC would be wholly owned by the Estate and formed solely to hold this single asset. The motion does not address capitalization, operational structure, or other features that would demonstrate how the proposed entity would materially alter the Estate's position as an interest holder, as opposed to merely changing the form in which title is held.

The Court requests further clarification as to whether the proposed transaction provides a substantive benefit rather than simply a formal change in ownership structure as well as a more fulsome demonstration of Trustee's business justification under § 363(b).

Trustee should appear and be prepared to address the foregoing.
