The Court is inclined to GRANT relief and permit Movant to proceed to a final judgment, upon which it may not execute against Debtor or Debtor's estate, for the reasons stated in the moving papers and the reply.

Movant seeks relief from stay to continue with a state court action, in which it is a defendant and a cross-complainant, against both Debtor and Debtor's principal, Mike Rafipoor. While neither Trustee, nor Debtor opposed this motion, Mr. Rafipoor did.

Movant argues that application of the factors found in *Truebro, Inc. v. Plumberex Specialty Products, Inc. (In re Plumberex Specialty Products, Inc.),* 311 B.R. 551, 559 (Bankr. C.D. Cal. 2004) weigh in favor of granting relief as this case is a corporate Chapter 7 and Debtor is not eligible for a discharge, neither Debtor nor Trustee filed an opposition, the underlying state court action is more than 5 years old, this case was filed on the eve of a scheduled trial, there are other non-debtor parties to the action, and the matter involves primarily state law issues. Movant also argues in its reply that Mr. Rafipoor's legal citations are misguided and unpersuasive and that to the extent Mr. Raifpoor, a non-debtor, seeks a stay, he was required to seek an

(In re Excel Innovations, Inc.), 502 F.3d 1086, 1095 (9th Cir. 2007) (noting that Ninth Circuit has "consistently held that the automatic stay does not apply to suits against non-debtors" and holding that "the usual preliminary injunction standard applies to stays of proceedings against nondebtor"). # **Tentative Ruling:**

Tentative for 5/7/25:

For the reasons set forth below, the Court is inclined to find that creditor, LoCali Management Group, LLC ("Landlord" or "Creditor") willfully violated the automatic stay and award damages, as set forth below.

Debtor filed a Chapter 13 on April 2, 2025, with Judge Houle presiding. Upon being informed that she was in danger of being evicted post-petition, without the Creditor having obtained relief from stay, Debtor filed an emergency motion to enforce the automatic stay on April 22, 2025 [Dk. 13] ("Emergency Motion"), which was set for hearing on Judge Houle's calendar for May 8, 2025 [See Dk. 15]. After Debtor's conversion to Chapter 7 on April 29, 2025, this case was transferred to this Court and the hearing on the Emergency Motion was placed on this Court's calendar and advanced to May 7, 2025.

On April 29, 2025, Debtor filed a Supplemental Declaration [Dk. 26] which served to supplement the Emergency Motion, detailed the events surrounding the post-petition eviction which occurred on April 23, 2025, and detailed Debtor's out of pocket damages totaling \$2,336 as of the date of the declaration. The Supplemental Declaration also includes a request for punitive damages related to emotional distress allegedly suffered by her as a result of the post-petition eviction.

Creditor essentially asserted to Debtor that it was not bound by the automatic stay as it obtained a pre-petition judgment and, indeed, an exception to the automatic stay does exist under certain circumstances under 11 U.S.C. §

362(b)(22). Under the facts of this case, however, § 362(b)(22) does not help Creditor. While the Creditor obtained a pre-petition default judgment for possession of the property in its unlawful detainer proceeding, Debtor obtained a pre-petition stay of enforcement of that judgment, with the state court judge ruling that: "the lockout is stayed pending a ruling on the Motion to Set Aside Default and Default Judgment." See Ex. D to her Decl. at Dk. 26; C.C.P. § 1176 ("An appeal taken by the defendant shall not stay proceedings upon the judgment unless the judge before whom the same was rendered so directs"). Debtor's bankruptcy was filed before the state court issued a ruling with respect to the Motion to Set Aside Default and Default Judgment. Thus, enforcement of the judgment was prohibited until further order of the state court and the judgment was not "final." See, e.g., Nicholson v. IFG Timber, L.L.C. (In re Nicholson), 2019 Bankr. LEXIS 1921, \*8 (9th Cir. BAP 2019) ("Thus, for the exception to the automatic stay to apply [under § 362(b)(22)], the landlord must obtain a final, non-appealable judgment for possession prior to the debtor's bankruptcy filing").

Therefore, as argued by Debtor in her Supplemental Declaration, the exception to the automatic stay under 11 U.S.C. § 362(b)(22) did not apply. The post-petition state court ruling on Debtor's motion to vacate the default judgment, which effectively lifted the state court stay, was a substantive ruling in violation of the automatic stay and is therefore void. *Schwartz v. United States (In re Schwartz)*, 954 F.2d 569, 571 (9th Cir. 1992) ("[V]iolations of the automatic stay are void, not voidable").

To award damages under § 362(k) for violation of the automatic stay, the bankruptcy court must find that the creditor willfully violated the stay. *In re Wallace*, 2014 WL 1244792, at \*4 (B.A.P. 9th Cir. Mar. 26, 2014) (unpublished) (citing *Knupfer v. Lindblade (In re Dyer).* "A violation of the stay is thus willful when a creditor acts intentionally with knowledge of the bankruptcy." *Mwangi v. Wells Fargo Bank, N.A. (In re Mwangi)*, 432 B.R. 812, 824 (B.A.P. 9th Cir. 2010) (citing In re Abrams, 127 B.R. 239, 243 (B.A.P. 9th Cir. 1991)).

Debtor has presented evidence that Creditor acted intentionally, with knowledge of the bankruptcy, and violated the automatic stay under 11 U.S.C. § 362, subjecting itself to sanctions under 11 U.S.C. § 362(k).



The response does not address why the successive filing was not an abuse as Debtor did not seek reconsideration of the prior dismissal, nor file an appeal.

At the prior hearing, where Debtor was represented by competent and well respected counsel, the Court made findings on the record regarding the abusive nature of the filing.
