ARM's objections to the Fee Application are limited to fees incurred in relation to services rendered in the categories "Claim Objection--ARM MJOP," and "Claim Objection--McClintock," on grounds that those services are "grossly excessive" for reasons ARM intends to detail in a pleading that has not yet been filed.
