There are two lien holders secured by Real Property, (1) FCI Lenders and (2) Investment Management. The Motion seeks to make payments to both secured lenders, pay property tax and insurance, and maintenance. Both secured lenders appear to be over secured with an equity cush of well over 100%. Investment Management, the 2nd lien holder, filed a conditional opposition reserving their rights and seeking, in addition to the adequate payments proposed by Debtor, a replacement lien.

In the Ninth Circuit, a 20% cushion has been held to be an adequate protection for a secured creditor. *In re Mellor*, 734 F.2d 1396, 1401 (9th Cir. 1984) (citing *In re McGowan*, 6 Bankr. 241, 243 (B.Ct. E.D. Pa. 1980) [holding a 10% cushion is sufficient to be adequate protection]. As Investment Management has an equity cushion of over 100%, will be receiving adequate protection payments, and has failed to show a decline in value in their interest, the Court is inclined to overrule the Opposition.

The Court requires clarification as to the following:

- 1. Whether the \$43,108.17 being sought for the first payroll period has already been paid and if so, whether the \$100,000 in Debtor's bank account is the balance after payment of this amount.
- 2. What other administrative post-petition obligations are anticipated to occur on a monthly basis?
- 3. What is the anticipated average monthly income of Debtor?
- 4. Whether the funds sought to pay the wages are cash collateral?
- 5. What is meant by "Jason Landver ... receives a monthly consulting fee from the Debtor through his company, Howard Enterprises."
