Tentative for 9/16/25:

This tentative applies to matters ##1-4.

Judgment was entered on January 14, 2015 against Marisa and Peter Nelson in the amount of \$921,501.63 under 11 U.S.C. § 523(a)(6), incorporating a stipulation requiring monthly installment payments of at least \$1,000. Debtors made payments through October 31, 2015, then defaulted.

Debtor Marisa Nelson seeks to vacate the Judgment and quash both examinations, arguing the Judgment expired under CCP § 683.020's 10-year limitation. However, this was an installment judgment, and under CCP § 683.030, the 10-year period runs separately as to each installment from its due date. Because payments were made through October 31, 2015, the first unpaid installment became due November 1, 2015. That installment will not expire until November 1, 2025.

Accordingly, the Judgment remains enforceable, and Debtor's arguments under CCP §§ 683.020 and 683.130 are unavailing.
