Debtor argues that the stay should be continued and the present case was filed in good faith because dismissal in the previous case was due to vaguely stated mistake/inadvertence in Debtor's understanding of how and when to tender plan payments. No specifics nor evidence are provided. Additionally, Debtor contends that the Property is of consequential value to the estate because the fair market value is greater than all the liens on the Property, and it is Debtor's principal residence which is necessary for Debtor's and his family's welfare. Debtor intends to tender pre and post confirmation payments for the ongoing mortgage of Mr. Cooper directly to him and proposes a repayment plan to cure all deficiencies owed to Mr. Cooper. Per the Castaneda requirements, Debtor has filed this motion and provided proper notice and hearing. The hearing is being held on December 3, 2024, which is prior to the 30 day expiration period. Finally, Debtor has rebutted the presumption of bad faith filing in showing that there is significant equity in the Property to pay off the loan through plan payments. Why these plan payments were not made the first time is unclear. Debtor claims to have not understood how to tender the plan payments and suggests that the mistake was due to his attorney's neglect. However, the specifics are not provided. Given that there is no opposition, particularity by Mr. Cooper as creditor, the court will grant the motion as unopposed, but the Debtor should use this second chance to understand his obligations in this bankruptcy or utilize the expertise of his counsel to help him to do so. Further defaults will not be treated with the same indulgence.
