The deadline for the debtor to file a chapter 11 plan and related proposed disclosure statement is January 30, 2026 [doc. 76]. **The debtor MUST NOT serve the chapter 11 plan and/or proposed, unapproved disclosure statement on any parties in interest, unless a party in interest obtains a copy through CM/ECF or requests a copy of the chapter 11 plan and/or proposed disclosure statement from the debtor's bankruptcy counsel, e.g., after that party in interest receives notice of a hearing on the adequacy of the proposed disclosure statement for solicitation of votes.**

No later than **April 1, 2026**, the debtor in possession or any appointed chapter 11 trustee must file and serve on the debtor's 20 largest unsecured creditors, all secured creditors and the United States trustee a status report, discussing the debtor's progress to confirmation of a chapter 11 plan, which status report must be supported by evidence in the form of declarations and supporting documents.

The Court will prepare the order setting the above deadline and continuing the chapter 11 case status conference.

The Court will confirm the *Plan of Reorganization for Small Business Under Chapter 11* (the "Plan") [doc. 36].

Pursuant to Local Bankruptcy Rule ("LBR") 3020-2(b)(2), no later than **14 days** after the date of the entry of the order confirming the Plan, the debtor must file a report stating whether the Plan has been substantially consummated and, if not, providing a projected date when substantial consummation is expected to occur and the steps necessary for substantial consummation to occur.

In addition, pursuant to LBR 3020-1, the debtor must file and serve a postconfirmation status report in accordance with LBR 3020-1(b) and (c). The first postconfirmation report must be filed no later than **May 20, 2026**. *See* LBR 3020-1(c).

The postconfirmation status report must be served on the United States trustee and the 20 largest unsecured creditors. *See* LBR 3020-1(b). The postconfirmation status report must comply with the provisions of LBR 3020-1(b) **AND BE SUPPORTED BY EVIDENCE**. A postconfirmation status conference will be held at **2:00 p.m. on June 3, 2026**.

The debtor must submit the confirmation order within seven (7) days.
