The chapter 7 trustee (the "Trustee") has not provided evidence in support of her position that the lien of Sunbelt Rentals, Inc. ("Sunbelt") is subject to a bona fide dispute under 11 U.S.C. § 363(f)(4).

Similarly, the Trustee has not provided evidence in support of her position that Sunbelt can be compelled to accept money satisfaction, if any, on its lien under 11 U.S.C. § 363(f)(5) because Joseph Sternlib, the debtor's principal, guaranteed the debt underlying Sunbelt's lien.
