Tentative Ruling:

The Court will deny the motion (the "Motion") [doc. 73].

According to the movant, as of August 7, 2025, the total postpetition delinquency was \$6,072.21. Declaration of Roselia Chavez, ¶ 12.f [doc. 73]. In addition, the movant asserted that an additional postpetition payment of \$2,142.96 would come due on August 1, 2025. *Id.*, ¶ 12.g.

On August 27, 2025, the debtor filed a response to the Motion (the "Response") [doc. 77] and attached his declaration ("Vera Decl.") in support. In his declaration, the debtor states, in part, that "[o]n August 19, 2025, I sent a cashier's check in the amount of \$8,251.17, representing mortgage arrears up to and including August 2025 to Select Portfolio Servicing by priority express mail, tracking number ED 252 761 056 US. See attached Ex "A"." Vera Decl., ¶ 2. To his declaration, the debtor attached as Exh. A a copy of a cashier's check dated August 19, 2025, in the amount of \$8,215.17 and what appears to be a screenshot confirming delivery of the check via U.S. priority mail. *See* Exh. A to the Vera Decl.

As of November 7, 2025, the movant has not filed a reply to the Response.

Given that the debtor has cured his postpetition arrears, the Court will deny the Motion.

The Court will grant the motion, including as to the debtor's real property/residence located at 4663 Kraft Ave., North Hollywood, California (the "Property"), on an interim basis up to the date of the continued hearing. The Court will continue this hearing to **9:30 a.m. on December 18, 2025.**

On October 27, 2025, the Court entered its *Order Granting on an Interim Basis and Continuing Hearing on Motion for Order Imposing a Stay or Continuing the Automatic Stay* (the "Order") [doc. 35]. The Order provides, in relevant part:

Unless Debtor has filed an amended plan to surrender [the Property], Debtor must timely pay the full deed of trust payments in accordance with the promissory note and deed of trust attached to the Objection to Confirmation of Plan [doc. 27], which come due post-petition to Secured Creditor RCAF Loan Acquisition, LP, as serviced by New Rez LLC dba Shellpoint (hereinafter "Shellpoint"), as well as her proposed chapter 13 plan payments to the chapter 13 trustee.

Debtor must file an amended chapter 13 plan on or before November 6, 2025, in which Debtor proposes either: (1) to surrender the Property; or (2) to maintain and directly make the contractual deed of trust payments to Shellpoint and to pay prepetition arrears owed to Shellpoint through the amended plan, subject to any agreement Debtor may otherwise make with Shellpoint concerning its deed of trust.

No later than November 6, 2025, Debtor must file a declaration with supporting documentation which demonstrate that Debtor timely made

On November 6, 2025, the debtor filed her first amended chapter 13 plan (the "Plan") [doc. 37]. In the Plan, the debtor proposes to make plan payments of \$950 per month for 60 months. Plan, p. 3. With respect to Shellpoint's claim, the debtor proposes: (1) to pay prepetition arrears of \$45,444.49 to Shellpoint through the Plan; and (2) to maintain and make the current contractual installment payments on Shellpoint's claim by making direct payments. *Id.*, p. 6.

The same day, the debtor filed her declaration regarding payments to Shellpoint and the chapter 13 trustee (the "Prado Decl.") [doc. 38]. In her declaration, the debtor states, in pertinent part:

Attached hereto are true and correct copies of the payment to Shellpoint for the post-petition contractual payment for the month of October in the amount of \$12,804.61 which is paid by my former husband who has agree [sic] to help save the home for the sake of our son...

Also attached hereto is a true and correct copy of my [chapter 13] plan payment...

Prado Decl., ¶¶ 3 and 4. Attached to the Prado Decl. is a copy of a personal check, apparently from the account of Jack Eliakim, dated November 6, 2025 and made payable to "Shellpoint," in the amount of \$12,804.61 (the "Personal Check"). Also attached to the Prado Decl. are two photographs depicting that a chapter 13 plan payment of \$950 was scheduled to be made through the TFS online portal on November 8, 2025.

No later than November 20, 2025, the debtor must serve on all secured creditors notice of the continued hearing date and time and the deadline to file and serve on the debtor and her counsel, **on or before December 4, 2025**, any response.

Tentative Ruling:

On December 11, 2023, plaintiff filed a complaint against defendant, initiating this adversary proceeding. After the first status conference, the Court entered a Scheduling Order which required that the parties file a pretrial stipulation by November 21, 2024. *Status Conference and Scheduling Order Pursuant to LBR 7016-1(a)(4)* [doc. 32].

On November 21, 2024, the parties filed a *Stipulation Extending Deadline to File Pretrial Stipulation and Continuing Pretrial Conference* [doc. 37], seeking to mediate their dispute. The Court approved this Stipulation, continued the pretrial conference to February 13, 2025 and ordered the parties to file a pretrial stipulation by January 30, 2025. *Order Approving Stipulation (1) Extending Deadline to File Pretrial Stipulation and (2) Continuing Pretrial Conference* [doc. 38]. On December 4, 2024, the Court entered an order assigning the dispute to mediation. *Order Assigning Matter to Mediation Program and Appointing Mediator and Alternate Mediator* [doc. 40]. The parties' mediation did not conclude with a settlement.

On January 23, 2025, the parties filed a *Stipulation (1) Extending Deadline to File Pretrial Stipulation and (2) Continuing Pretrial Conference* [doc. 43]; the parties requested that the Court continue the pretrial conference once again to allow more time for the parties to reach a settlement. On January 27, 2025, the Court approved this Stipulation, continued the pretrial conference to August 21, 2025 and ordered the parties to file a pretrial stipulation by July 31, 2025. *Order Approving Stipulation (1) Extending Deadline to File Pretrial Stipulation and (2) Continuing Pretrial Conference* [doc. 44].

On July 23, 2025, the parties filed a *Second Stipulation to Amend Scheduling Order, Continue all Dates to Allow Further Settlement Discussions* (the "Second Stipulation") [doc. 46]. On July 25, 2025, the Court approved the Second Stipulation, continued the pretrial conference to October 9, 2025 and set a deadline for the parties to file a pretrial stipulation by September 25, 2025. *Order Approving Stipulation (1) Extending Deadline to File Pretrial Stipulation and (2) Continuing Pretrial Conference* [doc. 47]. In that Order, the Court informed the parties that it would "not grant any further continuances based on settlement negotiations between the parties, and any future stipulation to continue based on another reason must be supported by a declaration signed under penalty of perjury and supporting documents." *Id.*

On September 25, 2025, the parties filed a *Third Stipulation to Amend Scheduling Order, Continue all Dates to Allow Parties to Document Settlement* (the "Third Stipulation") [doc. 50] and the *Declaration of Debra R. Brand* [doc. 51]. In the Third Stipulation, the parties represented that they agreed to a settlement on September 25, 2025, and they requested additional time to document that settlement. *Id.*

Based on the Third Stipulation, the Court continued the pretrial conference to November 13, 2025 and set a deadline of October 30, 2025 for the parties to file a pretrial stipulation.

The parties have not submitted a pretrial stipulation nor a stipulation to dismiss this adversary proceeding - which has been pending since December 2023.

Pursuant to Local Bankruptcy Rule 7016-1(f) and (g), the Court will dismiss this adversary proceeding for failure to prosecute.
