**Tentative Ruling:**

Debtor has not provided proof that it served the Motion as required by Rules 2002(c) (11) and 6004(f)(1) of the Federal Rules of Bankruptcy Procedure.

Wells Fargo Bank NA and the IRS, both of which had filed claims before the Motion was filed, do not appear on the service list attached to either the Notice of Motion or the Motion. While the IRS filed an amended proof of claim after the Motion was filed, reducing its claim to zero, the IRS remains on the list of creditors. The Court notes that the Franchise Tax Board has also filed a proof of claim in this Case; however, it was filed after the Motion had been filed.

In addition, Debtor failed to cite any authority in support of its request to pay all creditors out of escrow.
