The objection to the exemption is SUSTAINED. The failure of the debtor to file written opposition at least 14 days prior to the hearing as required by LBR 9013-1(h) is considered as consent to the sustaining of the objection. LBR 9013-1(h). Cf. Ghazali v. Moran, 46 F.3d 52, 53 (9th Cir. 1995). Further, the chapter 13 trustee has established a prima facie case for granting the relief requested. The debtors are not permitted to claim the exemption in the checking and savings account totaling \$12,258 under CCP § 704.225 since they do not satisfy the requirement to claim this exemption. The chapter 13 trustee shall submit an appropriate order. **No appearance is necessary.**
