Final Ruling:

This motion has been set for hearing on the notice required by LBR 3007-1(b). The failure of any party in interest to file written opposition at least 14 days prior to the hearing as required by LBR 9013-1(f) is considered as consent to the granting of the motion. LBR 9013-1(h). *Cf. Ghazali v. Moran*, 46 F.3d 52, 53 (9th Cir. 1995). Where a claimant does not timely file and serve a response, the court may sustain the objection without a hearing. LBR 3007-1(b)(6). Further, because the court is granting the relief requested by the moving party and for which a prima facie case has been established, an actual hearing is not necessary. *See Boone v. Burk (In re Eliapo)*, 468 F.3d 592, 602 (9th Cir. 2006). Their defaults are entered and the matter will be resolved without oral argument. LBR 9013-1(j)(3). **No appearance is allowed.**

No opposition was filed.

The Debtors' objection to proof of claim ("Claim No. 10") filed with the court's Claims Register by Wilshire Consumer Credit is SUSTAINED. Debtors have established a prima facie case for granting the relief requested. The court disallows Claim No. 10 as the four-year statute of limitations has expired on the account under California Code of Civil Procedure 337.
