Debtor seek to value debtor's PERSONAL PROPERTY, 2013 Mercedes-Benz E350 Sedan AWD, at a retail sale value of \$8,525.00. The subject property is secured by an interest held by First Investors Financial Servicing, securing a loan with a balance as of the petition date of approximately \$21,475.03. The valuation motion is supported by evidence as to the retail value of the subject property. The content of the notice meets the due process requirement that it be "reasonably calculated, under all of the circumstances, to apprise interested parties of the pendency of the action and to afford them the opportunity to present their objections." Mullane v. Central Hanover Bank & Trust Co., 339 U.S. 306, 314 (1950). Therefore, Infiniti Finance Services' claim is only partially secured by a deed of trust lien.

The debtor's motion is GRANTED. First Investors Financial Servicing's claim will be allowed as a secured claim in the amount of \$8,525.00 and an unsecured claim in the amount of \$12,950.03. 11 U.S.C. § 506(a). As a result, the chapter 13 plan must provide for full payment of the secured portion of the claim over the life of the plan and pay the unsecured portion of the lien with other unsecured claims. 11 U.S.C. §1325(a)(5)(B); see In re Enewally, 368 F.3d 1165, 1171-1172 (9th Cir. 2004), cert. den. 543 U.S. 1021, 125 S.Ct. 669 (2004). **Appearances waived.**
