The Ninth Circuit first set forth the established standard that scope of relief from the automatic stay for "cause" includes annulment of such stay and that the bankruptcy court has "wide latitude" in crafting such relief. In re Kissinger, 72 F.3d 107, 109 (9th Cir. 1995). According to the Ninth Circuit BAP, "the proper standard for determining 'cause' to annul the automatic stay retroactively is a 'balancing of the equities' test." In re Fjeldsted, 293 B.R. 12, 24 (9th Cir. BAP (Cal.) 2003) citing In re Nat'l Envtl. Waste Corp., 129 F.3d 1052, 1055 (9th Cir. 1997). Here, on balance, the factors enumerated in Fjeldsted weigh in favor of granting annulment of the stay. The movant had no notice of the debtor's bankruptcy when it violated the stay and the debtor's
