**Tentative Ruling:**

**Final Ruling.** No opposition has been filed. This application for compensation has been set for hearing on the notice required by LBR 2016-1(c)(4).  
**No appearance is necessary.**

The Court conducted an initial hearing on November 7, 2023 and, for the reasons discussed, continued the matter to January 23, 2024. The trustee then filed an amended application which proposes to pay \$8,000 to general unsecured creditors. These funds will pay general unsecured creditors 95% of their claims which is an excellent result. The fees and costs requested by the trustee and his professionals are well earned and the Court thanks them for their efforts.

Pursuant to the trustee's amended final report [docket #76], the following administrative claims will be allowed:

- (1) Trustee: fees of \$2,116.95 and expenses of \$115.47.
- (2) Shulman Bastian Friedman & Bui LLP, Attorney for Trustee: fees of \$9,237.60 and expenses of \$115.47.

The trustee shall prepare and upload a proposed order after the date and time of the hearing but no later than seven days thereafter. *See* LBR 9021-1(b)(1)(B) (stating that proposed orders shall be submitted "within 7 days" of the hearing but "must not be lodged prior to the hearing . . .").
